### Job Title: Director of Aquatics and Safety

FLSA Status: Exempt Reports to: Director of Operations

#### **Position Summary:**

Under the supervision of the Director of Operations, the Director of Aquatics and Safety leads the aquatic programs including oversight and delivery of lifeguarding, swim lessons, private lessons, aquatic exercise classes, lifeguard certification classes, CPR and First Aid classes, safety trainings, and aquatic training events. The Aquatics Director is responsible for managing and implementing all aquatics programming ensuring quality delivery of programs meeting the needs of the YMCA and the community. The Director of Aquatics will have direct supervision responsibilities of Lifeguards, Swim Instructors, Aquatic Instructors, and CPR/FA Instructors.

#### **Essential Functions:**

- 1. Directs and supervises program activities to meet YMCA objectives. Establishes new program activities and expands program within the community in accordance with strategic and operating plans.
- 2. Recruits, hires, trains, develops, schedules, and supervises personnel and volunteers in all assigned areas. Reviews and evaluates staff performance. Develops strategies to motivate staff and achieve goals. Ensures records of staff certifications are current and complete.
- 3. Monitors daily pool operations to adhere to all state, local and YMCA health and safety regulations, ensuring that pools meet all health and safety standards including a clean environment, appropriate air and water temperature, chemical balance, and timely pool water testing and backwashing.
- 4. Develops and monitors program budget to meet fiscal objectives.
- 5. Conducts lifeguarding, swim instruction, First Aid and CPR trainings.
- 6. Keeps accurate records of all safety trainings of staff throughout the organization.
- 7. Compiles program statistics. Monitors and evaluates the effectiveness of and participation in program.
- 8. Responsible for the safety of the building and scheduling safety drills and department trainings throughout the year.
- 9. Assists in YMCA special events.

Instructor, Certified Pool Operator Certification. Also requires trainer-level certification in YMCA/ARC Swim Lessons.

4. YMCA Team Leader certificate within three years.
