# **Position Summary:**

Provides direct leadership, instruction and motivation for students in swimming classes.

#### **Essential Functions:**

- 1. Instructs swimming lessons as assigned in accordance with YMCA guidelines, having prepared lesson plans accordingly.
- 2. Develops positive relationships with members and participants and provides motivational support and guidance.
- 3. Conveys information on aquatics programs and schedules and as appropriate refers members and participants to other programs.
- 4. Maintains records as required (i.e. attendance, progress reports, etc.).
- 5. Attends staff meetings and trainings as scheduled.
- 6. Follows all YMCA policies, rules, regulations and procedures, including emergency and safety procedures. Completes incident and accident reports as necessary.
- 7. Organizes and puts away needed class equipment. Reports damaged equipment.
- 8. Trains and supervises class aides as assigned.
- 9. Communicates and works with Aquatics Coordinator to find a substitute when absent from work.
